## Registered Reports, Pre-Data or Post-Data

There are two types of Registered Reports:

- Registered Reports – Pre-Data, i.e., before any data have been gathered

- Registered Reports – Post-Data, i.e., before already existing data have been examined and analyzed.

These submissions are reviewed in two stages. In Stage 1, a study proposal is considered for publication prior to data collection and/or analysis. Stage 1 submissions should include a complete Introduction, Methods, and Proposed Analyses. High-quality proposals will be accepted in principle before data collection and/or data analysis commences. Once the study is completed, the author will finish the article including Results and Discussion sections (Stage 2). Publication of the Stage 2 submission is guaranteed as long as the approved Stage 1 protocol is followed and the conclusions are appropriate. Full details can be found [here](#). The Journal's manuscript requirements should be adhered to for the stage 2 submission.

*The CJP* does not publish **clinical trial protocols, case reports or book reviews**.

For any manuscript invited by the Editor, please upload confirmation from the Editor upon submission.

**Abbreviations and acronyms.** If they are used only once, they should be spelled out and not abbreviated. If used more than once, the abbreviation or acronym should be spelled out in the text on first use, with the abbreviation in parenthesis.

**Measurements and weights** should be given in standard metric units.

**Statistical Nomenclature and Data Analysis.** Methodology for all statistical analysis should be described and references should be cited. Use of standard tests (chi-square test, student's T-test, etc.) do not require citation of references. Use of proprietary software for statistical analysis should be documented.

**Footnotes.** Type footnotes at the bottom of the manuscript page on which they are cited.

**Suppliers.** Credit suppliers of drugs, equipment, and other commercial material mentioned in the article within parentheses in text, giving company name, city and state or city and country.

The journal conforms to the [ICMJE requirement](#) that clinical trials are registered in a [WHO-approved public trials registry](#) at or before the time of first participant enrollment as a condition of consideration for publication. The trial registry name and URL, and registration number must be included at the end of the abstract.

## Formatting your manuscript

### Accepted file types

The preferred format for your manuscript is Word. You do not need to follow a template, but please ensure your heading levels are clear, and the sections clearly defined.

Preferred format for the text and tables of your manuscript is Word in 12 point Arial or Times New Roman fonts. Tables may be formatted in Word or Excel. The text should be double-spaced throughout and with a minimum of 3cm for left and right hand margins and 5cm at head and foot. Figures should be no longer than one page. Correct preparation of the manuscript will expedite the review and publishing process. Incorrectly formatted documents or those that are above the word count limit or are missing important elements will be returned to the author for correction prior to peer review, thus delaying peer review, decision, and publication.

### Title

Your manuscript's title should be concise, descriptive, unambiguous, accurate, and reflect the precise contents of the manuscript. A descriptive title that includes the topic of the manuscript makes an article more findable in the major indexing services.

### Abstract

Please include a structured abstract of Less than 300 words between the title and main body of your manuscript that concisely states the purpose of the research, major findings, and conclusions. If your research includes clinical trials, the trial registry name and URL, and registration number must be included at the end of the abstract. Submissions that do not meet this requirement will not be considered.

#### Plain language summaries

#### Keywords

#### Title page

To ensure fair and anonymous peer review, your manuscript must be fully anonymized. #### Acknowledgments

#### Consent for publication

  - Do not use vertical lines.
  - Each table should be numbered (Arabic) and have a title above. Legends and explanatory notes should be placed below the table.
  - Abbreviations used in the table follow the legend in alphabetic order. Lower case letter superscripts beginning with “a” and following in alphabetic order are used for notations regarding statistics.
  - Tables must not be imported or pasted as images.
  - Figure legends should be numbered (Arabic) and double-spaced in order of appearance. Identify (in alphabetical order) all abbreviations appearing in the figures at the end of each legend. Give the type of stain and magnification power for all photomicrographs.
  - Cite the source of previously published (print or electronic) material in the legend and indicate permission has been obtained. Proof of permission must be scanned and uploaded with manuscript files or emailed to the editorial office.

Additional Considerations: You will need to provide signed permission forms for any third-party content that is included in the text or video (images, graphics, etc.). Authors will need to secure Audio-Visual release forms if there are identifiable individuals (non-authors) in the videos.

- We encourage all authors and co-authors ensure their ORCID IDs are linked to their accounts in the submission system prior to article acceptance, as this is the only way to have their ORCID ID present on the published article. **ORCID IDs cannot be added to manuscripts after acceptance/publication.**

Your manuscript will undergo an initial evaluation. If it does not conform to the requirements laid out in these guidelines, it will be returned to you for amendments prior to peer review. Manuscripts may be desk rejected without peer review at this point if they are out of scope for the journal or otherwise unsuitable.

After passing the initial evaluation, your manuscript will then be peer reviewed. You can log in at any time to check the status of your manuscript. We will notify you when a decision has been reached.

The CJP recognizes the value and importance of peer review in maintaining the integrity of the scientific record. The peer review process is essential to scholarly publication both as a critique and a collaboration to improve the quality of the manuscript.

The journal operates a conventional single-anonymized reviewing policy in which the reviewer's name is always concealed from the submitting author.
